## ***Pawsitively Unleashed! Liability Waiver and Customer Agreement***

This agreement is made between Pawsitively Unleashed! and the undersigned customer, who makes the following acknowledgements and agrees to the following terms:

\_\_\_\_\_ (1) I agree that in admitting my dog(s) to Pawsitively Unleashed!, it is my representation that my dog(s) is/are in good health and have no signs of contagious diseases/infections or internal/external parasites including but not limited to fleas, ticks, roundworm etc. Pawsitively Unleashed! has the right to refuse any dog that does not meet health requirements.

\_\_\_\_\_ (2) I warrant and represent that my dog has no history of violence against people or other pets. I agree to indemnify and hold harmless Pawsitively Unleashed! in the event that my dog(s) causes harm to a person or another dog(s) while in the care of Pawsitively Unleashed!. Pawsitively Unleashed! has the right to refuse any pet that does not meet temperament requirements.

\_\_\_\_\_ (3) I agree to indemnify and hold harmless Pawsitively Unleashed! for any physical injuries, diseases, medical conditions or death of my dog(s) that may result from grooming, boarding or training at Pawsitively Unleashed!. I consent to allow my dog(s) to play with other dog(s) in a common area in group situations and acknowledge the possibility that physical injuries could result, such as scratches, cuts, tooth marks, bruising, pulled muscles, broken toe nails, dog bites, sore or injured pads, hair missing, or contracting diseases/infections (ie: kennel cough, parvo, fleas, etc) from other dogs.

\_\_\_\_\_ (4) I waive any and all claims, actions, or demands of any nature, foreseen or unforeseen, that I may have against Pawsitively Unleashed! relating to the care, control, health, and/or safety of my dog(s) arising from pickup, transport, drop-off and stay at Pawsitively Unleashed!.

\_\_\_\_\_ (5) I authorize Pawsitively Unleashed! to seek medical attention for my dog(s) to treat any and all serious medical conditions. I agree to pay for all medical expenses incurred as a result of medical treatment, and agree to reimburse Pawsitively Unleashed! in the event that Pawsitively Unleashed! incurs any costs involved in procuring medical treatment for my dog(s). In case of emergency whereas I **cannot** be reached or my designated emergency contact, I agree to allow:

- \$0-\$500 in medical treatment
- \$0-\$1000 in medical treatment
- \$0-\$2000 in medical treatment
- Do not administer care until I can be reached

\_\_\_\_\_ (6) I acknowledge that I am solely responsible for spay or neutering of my dog(s). In the event of insemination, I agree to hold Pawsitively Unleashed! harmless for their actions, and agree to be solely responsible for all expense as a result of any insemination.

\_\_\_\_\_ (7) I agree to pay for any and all damage to building or property at Pawsitively Unleashed! over and beyond normal wear and tear.

\_\_\_\_\_ (8) This Agreement shall be a complete incorporation of the parties' agreement, and shall be binding both parties during the course of Pawsitively Unleashed! services. The terms of this Agreement will be effective until revoked in writing by the Customer.

\_\_\_\_\_ (9) Any dispute arising out of this Agreement will be resolved in accordance with the laws of the State of Wisconsin, and litigated in Wisconsin State Court, in Portage County, WI. By signing this agreement, I acknowledge that I have read and understood all terms and agree to the terms and conditions contained herein.

## ***Pawsitively Unleashed! Rules & Regulations***

The mission of Pawsitively Unleashed! is to provide your dog(s) with a safe and caring boarding experience. To ensure the safety and health of your dog(s) and other guests, we require all guests to comply with the following rules and regulations:

### ***Hours of Operations:***

Boarding Check In/Check Out times:

Monday – Saturday      7:30 am – 11 am. & 3 pm – 8 pm  
Sundays & Holidays      By Pre-Arranged time

Grooming Hours:

All grooming is done by appointment only

Appointments available :

Tuesday– Friday from 7:00 am – 8 pm  
Saturday-Sunday from 9:00 am – 4 pm

***Check In/ Check Out:*** Reservations are required for all boarding, grooming and training classes. Pawsitively Unleashed reserves the right to decline any customer that does not have a reservation.

***Boarding Reservations:*** Boarding suites are available by reservation. Rooming charges begin the day your dog(s) is/are checked in. Check Out after 11 am will be charged for that day.

***Vaccinations:*** Pawsitively Unleashed! does not require vaccinations beyond Rabies as required by WI State Law. It is up to each individual to understand vaccinations, vaccination schedules or alternative approaches and titers.

***Health:*** All dogs coming to Pawsitively Unleashed! must be in good health. Owners will certify their dog(s) are in good health and have not been ill with a communicable condition in the last 15 days. Dogs that have been ill with a communicable condition in the last 30 days will require veterinarian certification of health to be admitted or readmitted.

***Kennel Cough:*** Pawsitively Unleashed! does not require the kennel cough booster as there are several strains of this infection and dogs with the vaccine are still susceptible. Kennel Cough (Bordetella) is a highly contagious upper respiratory infection. It is an airborne virus that pets commonly contract when they have had direct contact with other pets and/or have been exposed to an area where other pets have been.

***Flea Protection:*** Flea collars are NOT allowed. Customers are welcome to apply a flea/tick application. All dogs will be checked for signs of fleas upon arrival and will not be admitted if signs of fleas are noticed. Pawsitively Unleashed! is located in a rural area and ticks may be present during warmer months. If fleas should be noticed on any dog while in attendance at Pawsitively Unleashed! a flea treatment will be administered and the owner will be charged a minimum of \$25.00.

***Collars/Leashes:*** All owners must provide a collar. No choker, pinch or electronic collars are allowed. All dogs must come to Pawsitively Unleashed! on a leash or in a carrier. Please keep control of your dog at all times and prevent them from jumping up on other visitors or charging other dogs.

***Food/Medications:*** Owner's are encouraged to provide their dog's food. It is highly recommended to place in Ziplock bags with the correct meal portions to ensure your dog is given the proper amount of food for each mealtime. If owner's do not wish to provide food, a charge of \$2.00 per meal will be charged. Medications must be in a container (Ziplock bag, lidded container) with the dog's name and instructions written on it and the original container.

***Blankets/toys/beds:*** Owner's are allowed to provide their dog with a blanket or bed and toys from home, but Pawsitively Unleashed! assumes no responsibility for such items.

***Payment:*** Payment is due upon Check Out for boarding and/or grooming appointments and at time of enrollment for training classes/programs. We accept cash and check at this time.

***Cancellations:*** We must be notified of any grooming or boarding cancellation by phone or email. If a dog repeatedly does not show up for grooming appointments or boarding reservations without any notice, we have the right to refuse booking for any future services.

## ***Boarding Information***

What to bring:

- ✓ Dog Food – refrigeration is available for raw/prepared foods. You must provide enough food for your dog's entire stay (or a \$2.00 per meal fee will apply). It is preferred that food be premeasured for each feeding in a Ziplock or small lidded container with your dog's name written on it. If bringing food in a bag, feeding instructions and the dog's name must be attached to bag. Feed and water dishes are provided by Pawsitively Unleashed!
- ✓ A blanket or small bed may be brought along. Pawsitively Unleashed! assumes no responsibility for such items, but they will remain in your dog's suite.
- ✓ Medication must be in a Ziplock or lidded container with dog's name and clear instructions for administration. The original container must be sent along for emergency purposes.
- ✓ Toys may be provided but must not be easily chewed up and/or swallowed. Toys will remain in your dog's suite at all times.
- ✓ Your dog(s) will receive a lot of individual attention and care while at Pawsitively Unleashed!. this can include multiple walks and play time throughout the day. All dogs are "tucked in" by 10 pm for the night.
- ✓ Your dog's well being is of great importance to us. Please be sure to note any special instructions or routines your dog may need. We wish to make your dog's stay as pleasant and stress free as possible and will treat them as we would our own dogs.
- ✓ Dogs staying for more than 5 overnights are welcome to a complimentary bath. Grooming appointments can be made while your dog is at Pawsitively Unleashed! but must be made at time of reservation or check in to ensure there is ample room on the schedule.
